



- They provide 82.4 % of all training positions in NRW.








AROUND 20,000 FOREIGN COMPANIES IN NRW

- 21.3 % of the foreign companies are based in NRW.
- Foreign investors provide work for about 1 million people.
- Major investor countries are: the Netherlands, USA, Switzerland, Great Britain, France, VR China, Austria, Japan, Italy, Russia and Turkey.
- Approx. 1,500 UK companies in NRW
- Examples: Vodafone, Rentokil, AO, JCB, Dyson, Johnson Matthey, Lush, GKN, BP, JSP Safety Products.
